President's Message

The LWVB/N Board has approved the Legislative Priorities recommended for the coming year by the Issues Committee. The three issues selected were forwarded to the New York State League to be considered for selection as the Legislative Priorities for the LWVNYS. LWVB/N recommended Climate Change (which includes energy and environment, sprawl, alternative energy and transportation), Health care and Redistricting.

Climate Change (Global Warming) is the topic being presented at this year's UN Briefings on December 2nd. Co-president, Loretta Peszynski, and I will attend this program.

I also received a very interesting e-mail on this topic from Donna Ewing of LWVWA, who serves on the LWVUS Climate Change Task Force. I would like to share a little bit of that message with you.

“...An individual's carbon footprint is defined as the amount of carbon a person generates per year through daily activities such as driving an automobile, doing laundry, showering and maintaining a comfortable indoor temperature.

Climate change is developing into perhaps the most important crisis in human history – it will certainly impact every living thing on earth. Efforts to positively alter this life-changing phenomenon must be worldwide, and it would seem that those countries that have caused most of the problem should take initial responsibility for solving it. This is where you and I come in.

Since Americans generate from 25 to 28 percent of the world's greenhouse gas emissions, but we comprise less than 5 percent of the world's population, the most effective thing we can do is to lobby our elected officials to establish the laws that are essential to reduce these emissions.

These laws must require improved efficiency and conservation in the use of energy and a reduced dependence on fossil fuels (coal, oil and natural gas). Every elected official and/or candidate supported by us at every level of government must have a realistic plan to slow and, ultimately, stop climate change. We, as voting citizens, MUST demand no less! ...”

Charter School/ Education News

The opening in August of the Aloma Johnson Fruit Belt Community Charter School on Michigan Avenue in Buffalo brings the local total number of charter schools to 16. This newest one partners with Daemen College and with the St. John Fruit Belt Community Development Corporation. It features a longer school day of 8 hours and school year of 205 days. The Charter Schools/Education Committee is arranging a visit.

Two charter schools, Stepping Stones Academy Charter School and the Sankofa Charter School (formerly KIPP), have been closed as unsatisfactory. In October Shawn Fagan gave a presentation to the committee about her first hand experiences as a mother of a child enrolled at the KIPP School in Buffalo. We were given an articulate insight into the serious problems, which gradually led to the school's losing its KIPP name, and soon afterward being closed by the Board of Regents. Ms. Fagan has been employed in the legal profession for many years, and presently works in Buffalo City Court.

The Tapestry Charter School has purchased the 47,000 square foot building at 65 Great Arrow Drive. When it opens in the 2009-2010 school year, it will include the lower grades and the high school. Their goal is to have kindergarten through 12th grade in one location.

Teachers' unions have been cropping up in charter schools around the United States. At last summer's National Charter Schools Conference in New Orleans about 30 union-represented charter school teachers attended. Here in New York state about 12 charter schools are unionized.

The Washington Post has reported that efforts to expand charter schools may face difficulty securing credit to meet their regular business expenses because of the national financial crisis.

More than 100,000 students from over 100 local elementary, middle and high schools in 20 local school districts participated in KIDS VOTING in November. This important mock election, now held within the schools, introduces students to the importance of voting and civic involvement.

The next meeting of the Charter Schools Committee will be January 15, 2009 at 1:30 p.m.

Regional Waters Issues Update

New York and eight other states are suing the Bush administration over federal rules on water dumped from ships, claiming there is an illegal loophole that could hurt fisheries and contaminate drinking water. The states contend that a June administrative ruling could allow the transfer of polluted or contaminated water by ship from one body of water to another, where it would do harm. For example, they claim salt water from the ocean could be dumped in the Great Lakes. At issue in the lawsuit against the Environmental Protection Agency is regulation of water discharges from ballast and other sources on vessels large and small. The lawsuit also targets invasive species contained in ballast that could destroy lakes and rivers. Source: *Buffalo News*, 10/3/08

Something Old is New Again

In the Fall issue of the New York State League VOTER, there is an article under the heading "Something Old is New Again" concerning the operation of the State League. As implied in the title, the concept of state regions is an old idea. In fact, in the 1920s and 1930s, the Erie County and Niagara County Leagues were in the Eighth Region, which included Alleghany, Cattaraugus, Chautauqua, Genesee, Erie, Niagara, Orleans and Wyoming counties.

In this time period, of course, there were no Conference Calls so keeping in touch meant traveling throughout the state, and the various regions seemed to be set up to make it easier for local groups to meet in their areas.

In June 1927, a regional meeting was held in Geneva for the fifteen counties in Western New York. In 1929, a regional conference was held in Perry and was attended by about 200 women. This conference was covered extensively in the *Buffalo Times* newspaper.

During the 1930s, the Eighth Region's conferences moved closer to the Buffalo area and in 1931 and 1938, the conferences were held in East Aurora at the Roycroft. The 1938 conference was of special note to local League members as the chair of the Eighth Region was Mrs. Glenney, a former president of the Erie County League and the New York State League president, Mrs. Charles Poletti, the former Jean Knox of East Aurora, was in attendance. The 1932 conference of the Eighth Region was held in Lockport and was chaired by Mrs. Charles W. Moss, president of the Niagara County League.

The primary reason for these meetings was to communicate and share ideas on issues and programs and to learn about what works and what does not work in meeting the goals of the League of Women Voters locally, state wide and nationally.

The Buffalo Unit will meet on January 15, 2009, at the Karpeles Museum North Hall, 220 North Street (corner of Elmwood and North) at 5 p.m.

The Gantt-Robach (A.6399-C) Childhood Lead Poisoning Primary Prevention and Safe Housing Act supported by LWVNY passed in the NYS Assembly and Senate only to be vetoed by Governor Paterson. This legislation targets the solution to the problem and provides limited tax credits to give property owners the help they need to make their housing safe. When fully implemented this legislation will prevent tens of thousands of New York's most vulnerable children from the life-long damage caused by lead poisoning.
