President's Message

The board of directors of LWVBN has approved the budget proposed by the budget committee for 2010-2011. We thank Lyle Toohey, Terri Parks, Judy Weidemann, Deb Billoni, Joyce Bol and Judy Clarke for their work in preparing the proposed budget.

The nominating committee will submit its candidates to the board at its April meeting and to the membership in the Annual Meeting Packet that will be mailed to all LWVBN members at the same time as the May VOTER is mailed.

The Natural Resources committee visited the Waste Management facility in Chaffee, NY on March 8. The details for the ECO Tour at Daemen College for LWVBN on May 15 will be printed in the May VOTER.

We will conduct the Buffalo Municipal Housing Elections this spring. Volunteers are needed for many tasks including sorting and counting the ballots in early June.

The issues Committee appointed Lenore Banks, Anne Huberman and Therese Warden as a subcommittee to review our 2009-2010 Local Program and new proposals for our 2010-2011 Local Program. They will present their recommendations to the Issues Committee at its March meeting. The Issues Committee will present its recommendations for additions and revisions to local program for board action at its April meeting. The board's recommendations will be mailed in the Annual Meeting Packet for adoption at our annual meeting in June.

At the March board meeting, the board approved the League's support of a Women Leader's Statement requested by Voice Buffalo in response to cuts in services to women and children of Erie County, such as neighborhood health clinics and day care subsidies.

Janet Goodsell and other League volunteers are currently conducting interviews with local State Legislators. We all miss Loretta Peszynski's presence at our meetings and wish her a speedy recovery from her surgery at the end of January.

One of the highlights of spring 2010 will be the League's 90th Birthday Celebration. We are planning a gala birthday event to be held in conjunction with our annual meeting on June 5th.

I hope to see many of you at some or all of the upcoming events.

LWVBN is partnering with the Interfaith Impact of NY and the Social Justice task Force UUCB to present an up close view of one of New York State Government's most intractable problems, the perspective from Western New York, and steps all of us can take to reform the system. Ethics reform is a 2010 legislative priority for the League.

Ethics reform legislation (S6457) was passed by the State Legislature this past January and sent to Governor Paterson, who vetoed the bill. As of this writing the State Senate has tabled the motion to reconsider the Governor's veto, having failed to over ride.

Voicing support for S6457, the State League stated that the proposed changes would improve both ethics and campaign finance enforcement and create greater transparency. Specifically it would:

1. Strengthen the enforcement unit with in the State Board of Elections and increase transparency of filings and enforcement.
2. Create three new oversight agencies for ethics and lobbying.
3. Require more extensive disclosure from legislators and lobbyists.

While the proposed legislation does not include everything that the League sought, we believe these changes represent a substantial and necessary step forward on ethics and campaign finance enforcement reform. New York cannot afford the continuation of a flawed ethics oversight system.

(Make sure that no one is already on the bridge as it has only one lane.) Then drive straight ahead (west) to the river. Turn right under the International Railroad Bridge and drive to the end of the road where we will start our work.
