Discussion and Selection of Making Democracy Work Honoree – T. Parks Prior to the meeting, the board had received Making Democracy Work Award Applications for four nominees. After a discussion of the nominees' community contributions, leadership and impact, L. Robinson made a motion nominating Rev. Kirk Laubenstein as the 2018 Making Democracy Work Honoree. Motion seconded and approved.

N. DeTine offered to revise the Making Democracy Work Award Application for next year.

#### Treasurer Items – L. Robinson

L. Robinson circulated a letter from our accountant, J.J. Gutt and Associates, Inc. who audited our fiscal year ending in June 2017 and found our financial statements were in conformity with generally accepted accounting practices.

The LWVB/N 2017-2018 Budget was sent to the Board before the meeting to see if they would have any suggestions for the 2018-2019 budget.

- 2) Adding a line to the next budget for marketing and advertising was suggested.
- N. DeTine will ask S. Vernon about the cost of a Facebook ad for events and programs.

- 3) Membership Badges Add a line to the membership form to ask new members if they request a LWVB/N membership badge.
- 4) Budget for Annual Meeting The Board set the prices for the Annual Meeting at Fairdale Banquet Center.

Motion by L. Robinson and seconded that we have dessert at the Annual Meeting and Awards Luncheon on June 9, 2018. The cost should be \$25.00 for members and \$30.00 for non-members. Motion approved.

Student PMP/Students Inside Albany Awardees Membership - J. Massaro LWVUS has discontinued its practice of assessing student members PMP. There is no PMP assessment at the state level, so Leagues maintain 100% of the dues they charge student members.

Motion by J. Massaro and seconded that we present the two Students Inside Albany Awardees with a one-year complimentary student membership to LWVB/N. Motion approved.

### Pens for Naturalization Ceremonies – P. Wille

P. Wille received 300 pens with the League logo on them, 200 from a donation and 100 from the National Pen Company to be given to new citizens when they complete the Voter Registration Form at Naturalization Ceremonies. They will be available in batches of 10 to be picked up when Voter Registration Forms are picked up.

#### LWVUS Convention – N. DeTine

LWVB/N is entitled to four delegates to attend the national convention in Chicago from June 28 – July 1. Ramona Gallagher has already expressed an interest. Lori Robinson is also interested in being a delegate. The \$2000 budgeted for the convention will be equally divided among the attendees.

## West Valley Demonstration Project – T. Parks

Joanne Hameister, a League member is involved with the West Valley Demonstration Project. The Department of Energy and NYSERDA have begun the process for the final decision about the clean-up efforts and are asking for input during this process.

Joanne offered to make a presentation to the Board and present her power point program to the League. It was decided to refer her program offer to the Issues Committee and decline her presentation to the board. At present, LWVB/N does not have an Environmental Committee.

#### WNY Environmental Alliance – T. Parks
