### **...to protect, extend and encourage the use of the franchise**

The most interesting call that came into the League Office during election season was from a Niagara County woman who asked when the Permanent Personal Registration was enacted. Since she knew League was "involved with voting issues" she thought we might have the answer.

Indeed we did. The LWV New York State's *Impact on Issues* contained the following: "Permanent Personal Registration (PPR) became mandatory in 1967, primarily due to the unflagging pressure of the League of Women Voters." The campaign for PPR began in 1926 and, like many election reforms, began in controversy and took years to accomplish. A partial list of League backed reforms includes elimination of irrelevant information, such as employment status, from voter registration forms, purging of voter registration lists for failure to vote, mail-in and agency-based voter registration (Motor-Voter legislation), reduction of the 90 day residency requirement (it is now 30 days – the League advocates same day voter registration and expanding absentee and student voting opportunities). Our efforts to achieve election reform are ongoing.

We are now evaluating Electronic Voting Systems. League's point person for election law reform is Aimee Allaud. Aimee and Maggie Moehringer, Voter Service Chair for the State League, request our help in evaluating the "paper ballot optical scanning system" in use in some areas of the state this November. *If you used this system in the General Election in November, please respond to the survey below.* Thank you.

## Natural Resources News



Beneath the natural beauty of Allegany State Park and the surrounding community lie trillions of cubic feet of natural gas, trapped in the rock of the Marcellus Shale formation. Drilling companies propose to use a dangerous technique, hydraulic fracturing, often called "fracking" to extract this natural gas. Fracking needs millions of gallons of water and toxic chemicals per well. Already wells of nearby residents have been contaminated where drilling is permitted.

Currently, New York State's Department of Environmental Conservation is accepting input on a draft plan to regulate this drilling. To protect the health of our environment and natural resources, New York State must regulate this growing industry of gas drilling.

### Finally! At long last! The Bigger Better Bottle Bill is law!

**Green thinking from high school students:** A group of East Aurora High School students met with their principal and told him that all students will boycott food presented to them on plastic disposable plates. They asked for REAL plates that can be washed instead of throwaways. The principal called the vendor to speak with the students. Results are pending but my bet is that a way will be found to reduce the garbage currently being created.

We thank Phyllis Banas, moderator; Joan Herold and Nancy Smith, timekeepers; Judy Weidemann, organizer; and Joe Logan, videographer; for our Aurora Candidates' Forum on October 20. We send a big thank you to all the other Leaguers who helped.

Thank you, Leaguers Walter and Nan Simpson, Ellen Moomaw and Sandy Chelnov, who organized the local International Climate Change Event Oct 24 at D'Youville College. This global day of action was coordinated internationally by [350.org](http://350.org) and organized locally by the Western New York Climate Action Coalition and co-sponsored by LWVBN and a number of other local organizations. More than 5200 events in over 190 countries -- including an official underwater cabinet meeting in the Maldives, an area that will be flooded if global temperatures continue to rise-- took place on that day, bringing to the world's attention (often humorously) the need for a reduction of greenhouse gas emissions that meets what science is telling needs to happen: a drop of carbon dioxide emissions down to 350 parts per million. We are currently over that number at 387 ppm.

Along with many speakers and other performers, LWVBN members performed their Climate Change skit. Joan Photiadis narrated while Joan Herold, Ellen Moomaw and Ellen Neumaier played the parts of members of a League eco-team from our recent Low Carbon Diet program. The skit makes clear that as challenging as it might be to lower one's "carbon footprint", being on an eco-team is lots of fun! Leaguer Nancy Thayer made flags with "350" silk-screened on them for the parade to the waterfront where photos were taken to be uploaded onto the 350.org website together with tens of thousands of photos from around the world taken at climate actions that day.

### Tip of the Month from Delta's magazine: Use a Rake, for Goodness Sake!

**One hour** of using a gas-operated leaf blower produces the same amount of greenhouse gases as **driving a car 4,400 miles!** That's a round-trip from Salt Lake City to New York City.

### An Early Leader of Our Local League

Mrs. Berend J. Burns served as the fourth League chair in 1923 to 1924. Mrs. Burns, nee Margaret Broad, was a native of Buffalo, attended local public schools and graduated from Vassar College where she studied economics, history and sociology. After she graduated from Vassar, she was a member of the first graduating class of Teachers' Training School and became a member of the Masten Park High School faculty and conducted classes at a continuation school, a school for children who had to leave regular school to help support their families.

After her marriage to Berend J. Burns, a grain broker, and leaving the teaching profession, Mrs. Burns became active in the League. During her tenure as League Chair, the Erie County League of Women Voters hosted the 1924 National League convention.

After her term as chair, Mrs. Burns stayed active in the League. In the 1930s she served as chair of the Municipal Affairs Committee where she worked on the Election Bulletin. At this time she was also involved with the local LWV radio program series on political affairs. The program covered subjects such as city planning, off year elections and imprisonment or probation for women prisoners in Buffalo. Also because of her involvement with the continuation schools, they became a case study for the League. Mrs. Burns was also a much sought after member of the LWV Speakers Bureau and traveled throughout Western New York to convey the League's messages.

In addition to her work with the League, she traveled widely and was active in church mission work and the YWCA.

### State Consolidation/Shared Services Study

The LWVNYS 2009 Convention approved a new state study on local government consolidation and shared services. Noreen Fisher of the Scarsdale League is the chair of the study committee, and Anne Huberman is representing the LWVBN on that state committee.

Noreen has noted that consolidation is not limited to a simple merger of two local governmental units or the merger of school districts but also contemplates the consolidation of special districts such as fire, library, water, sewer, etc., the consolidation of local public authorities, and the consolidation of a municipal service without the loss of the underlying governmental units (e.g., civil service hiring, assessing, IT, purchasing, etc.), all with the intent of reducing costs. This considers a broader range of possibilities than those included in our recent LWVBN study. Having looked at the work we did and at our list of criteria, the committee is clearly drawing ideas from our study.

Committee members are still in the process of gathering information and deciding what to distribute to local leagues. In the meantime, they recommend that all League members planning on participating in the consensus process visit the following websites to begin to get up to speed:

Again because of time constraints, we were unable to produce a *Voter Guide* for Niagara County.

We thank Mike Egan, Janet Goodsell, Sandra O'Hara, Barbara Klobberdanz, and Ann Marie Malachowski for their help with typing and proofreading. We appreciate their help on these essential tasks. We are grateful for the guidance of Laura McDade and Joan Mondul who shared their experiences from previous *Voter Guide* preparation. And our thanks to Terri Parks for preparing the PDF version and the flyers announcing the online *Voter Guide* that were distributed to the Erie County Libraries and our members. We acknowledge the support of M&T Bank for their grant for printing costs.

Voter interest in election information was reflected by increased traffic at the LWVBN web site. The number of web site visits increased from 752 in September to 1379 in October. In the first three days of November there were 849 visits. The *Voter Guide* PDF was viewed 356 times.

## **Waterfront Committee News**

Other Leaguers and I attended The Erie Canal Development Corporation public hearing on Tuesday, October 20, to learn about the proposed "Canalside" Development Plan. The questions following the presentation ranged from complete approval to total disapproval. As this meeting was the first (generic impact) of many public hearings, I sent the League's position on waterfront development, which "supports coherent regional planning processes which are arrived at, and adopted with adequate public participation". The League's concern is always that public participation is not marginalized. Please stay tuned.

Tim Tielman, Executive Director of Campaign for a Greater Buffalo History, Architecture and Culture, spoke at the Marine Drive Apartments meeting to discuss with tenants their concern over "Canalside" plans to build a 1200 car-parking ramp at the proposed Bass Pro site, which would gravely impact their quality of life. I attended that meeting as a private citizen. It should be noted that the League in the past had worked with framers of the 2004 Inner Harbor Waterfront Plan that resulted in public access, restoration of the Erie Canal terminus site and other recent projects.
