Great Decisions

The LWVBN-sponsored Great Decisions group will commence its 2024 year on Thursday, March 7, at 10:00 a.m. via Zoom. We will organize future meetings and then discuss the first chapter in the 2024 Foreign Policy Association's Great Decisions book: "The U.S. and the Middle East." Here is a synopsis of the chapter:

Mideast Realignment by Marc Lynch

The United States and Middle East are at a crossroads. In spite of a reduced presence in the Middle East, the U.S. still has significant national interests there and the area is a key arena for global power politics. Can the U.S. continue to defend its interests in the Middle East and globally with a lower level of military and political involvement, or should it recommit to a leading role in the region?

The 2024 edition of Great Decisions was published in early 2024 and the chapter includes discussion of the October 7 attack so it is relevant to today's issues.

The Great Decisions group will continue its 2024 discussions on Thursday, April 4, at 10:00 a.m. via Zoom. We will discuss the second chapter in the 2024 book, titled "Global trade and green energy."

Here is a synopsis of the chapter:

Climate technology and competition by Bud Ward

Will the United States and China, with other powerful countries following suit, approach current and future climate initiatives with an increased commitment to trade protectionism and nationalism, by various measures including trade restrictions? Or could a growing spirit of international accord develop to confront the "common enemy" of climate change?

Equal Rights Amendment - New York State Promotion - Knitted Yellow Rose

Our friends in the LVW St. Lawrence County are launching a yellow knitted flower campaign in support of the New York Equal Rights Amendment. Beginning March 8 (International Women's Day), we are encouraging all New York knitters and crocheters to create yellow flowers to support the NY Equal Rights Amendment, which will be on the November 5, 2024, ballot.

The yellow knitted flowers are inspired by the yellow roses worn by the suffragists during their campaign for passage of the 19th Amendment and will be worn in honor of our foremothers in the suffrage movement as well as those working to move the ERA-NYS over the finish line.

The yellow flowers can be worn by all on a hat, scarf or lapel to show your support.



Yellow Rose Knitting Pattern

Pattern by Kristen McDonnell from Studio Knit

Materials - 42 yards worsted weight yarn

Knitting needles - Size 7 U.S. straight needles, tapestry needle, scissors

Cast on 6 stitches

Row 1 - Knit all stitches

Row 2 - K1, YO, *K1 (11 stitches)

Row 3 - Knit all stitches

Row 4 - K1, YO, *K1 (21 stitches)

Row 5 - Knit all stitches

Row 6 - K1, YO, *K1 (41 stitches)

Row 7 - Knit all stitches

Row 8 - K1, YO, *K1 (81 stitches)

Row 9 - Knit all stitches

Bind off

As you bind off, you will see your rose start to take shape by curling in as you are binding off.

Take one end and curl it into a rose shape. Tack it securely together using your yarn tail and a tapestry needle. Attach a 1 1/2" safety pin through the back.
